

TERMS OF USE

GENERAL TERMS

Please read these Terms of Use carefully. These Terms of Use (the "Agreement") should be read by you (the "user", "player" or "you") in its entirety prior to your use of BCH.games (the website and the games together referred to as "Service"). Please note that the Agreement constitutes a legally binding agreement between you and BCH.games [referred to herein as "BCH.games", "us" or "we"] which owns and operates the website and the games found at BCH.games ("BCH.games website" or "website"). By playing BCH.games games you agree to be bound by these Terms of Use and all terms incorporated by reference.

GRANT OF LICENSE

Subject to Terms of Use contained herein, BCH.games grants the User a non-exclusive, personal, non-transferable right to play the game on his/her personal computer or other device (including Mobile) that has Internet in order to access the game available and described on BCH.games website.

THE SERVICE IS FORBIDDEN FOR USE BY:

Individuals under 18 years of age.
Individuals under the legal age of majority in their jurisdiction.
Individuals accessing the Service from Jurisdictions from which it is illegal to do so.
Cryptocurrency gaming may be illegal in the Jurisdiction in which you are located. BCH.games is not able to verify the legality of the Service in each Jurisdiction and it is the User's responsibility to ensure that their use of the Service is lawful.

USER'S ACCOUNT

Every user has an account within the Website. User must sign in at website to play. E-mail is used to get a security code for account verification.

To play, you can make deposits into your account from a source of which you are the only legitimate owner.

BONUSES

Free faucet is an amount provided to user for free with certain frequency. Free faucet is used to give new users a possibility to try playing the game with real Bitcoin Cash without making a deposit. Faucet is not designed for earning. We reserve the right to change size and frequency of faucet without notice. Faucet farming is strictly prohibited, if detected, no BCH will be paid out and account will be terminated.

REFERRALS

BCH.games rewards users for sharing affiliate links and attracting users to website. BCH.games has one of the highest referral commission rates which can be found at Referral page. User can see number of referrals and total commission received for them at user's affiliate dashboard. Usernames of referred users can not be shown due to privacy reasons.

GAME RESULTS AFTER BROWSER ISSUES

BCH.games shall not have any responsibilities for any delays, game being stuck or frozen and losses that may occur because of that in the game. This can only happen because of your computer/device specific reasons or internet connection issues. When you press button to play, your game is instantly being processed on server. And the result is generated and fixed on server. If after the game is stuck you refresh website and see you lost the game, it means that the game was a losing one, with no regard to the freezing. But it is also true if you win.

CANCELLATION POLICY

We reserve the right to cancel or void any games in our absolute discretion, where in our reasonable opinion, there is an error in the game in question or there is technological failure. Unless a specific reference to the contrary is made in the description of the game, a game will be deemed not to have occurred in an event of technological failure. In such case, the game will be deemed to be void and all related funds deposited in respect of that game may be returned to member's account. However, games that have already been resolved at the time of cancellation will stand.

PAYOUT POLICY

The website allows playing with Bitcoin Cash.

A minimum withdrawal amount is indicated in the Cashout section. The maximum stake is a maximum sum allowed for a single stake and is indicated in the stake input. BCH.games reserves the right to increase or decrease Maximum stake at any time with no previous warning. In case of large withdrawals manual processing may be implemented.

The player understands that exchange rate for Bitcoin Cash can change significantly depending on the market fluctuations.

ANTI FRAUD

We have a strict anti-fraud policy. We reserve the right to terminate the user account and suspend all payouts to the player if the player is suspected of fraudulent actions including, but not limited to: - participating in any type of collusion with other users - development of strategies aimed at gaining of unfair winnings - fraudulent actions against other online gaming sites - other types of cheating or any other actions which may damage BCH.games.

This decision is at our sole discretion and the player will not be notified or informed about the reasons of such actions.

We have zero tolerance to advantage play. Any player who will try to gain advantage of BCH.games's bonus offers or other promotions agrees that BCH.games reserves the right to void bonuses and any winnings from such bonuses.

BCH.games reserves the right to retain payments, if suspicion or evidence exists of manipulation of the game system. BCH.games reserves the right to terminate and/or change any events being offered on Website. In no case shall BCH.games be liable for any special, incidental, indirect, punitive or consequential damages arising from your use of Service. Regardless of our efforts, we make no warranty that the service will be uninterrupted, timely or error-free, or that defects will be corrected. BCH.games retains authority over the issuing, maintenance and closing of the Service. You acknowledge and agree that your sole and exclusive remedy for any dispute with BCH.games is to stop using the service and to cancel all accounts registered.

YOUR REPRESENTATIONS AND WARRANTIES

It is prohibited to post false and/or offensive information about BCH.games on external resources (forums, blogs, social networks and other). It is prohibited to make deposits on your account for the purpose of withdrawing amounts, which were not allowed to be withdrawn due to minimum withdrawal limit restrictions. BCH.games prohibits player collusion. BCH.games strictly prohibits self-referral activities like creating second and other accounts to fake a real referral activity or any other activities, that abuse referrals. BCH.games reserves the right to block any account without any notice due to any suspicious or malicious activity or if it was inactive for the last 6 (six) months.

The User should not withdraw Bitcoin Cash to a shared wallet not solely controlled by the user or any other address not solely controlled by the user as any amounts sent to such address may not be properly credited to the user.

It is prohibited to share your account access details to third-parties.

JURISDICTIONS

Persons located in or reside in United States, Curaçao, Syrian Arab Republic, Islamic Republic Of Iran, The Democratic People's Republic of Korea, Australia, Netherlands or France (the "Prohibited Jurisdictions") are not permitted make use of the Service. For the avoidance of doubt, the foregoing restrictions on engaging in Bitcoin Cash play from Prohibited Jurisdictions applies equally to residents and citizens of other nations while located in a Prohibited Jurisdiction. Any attempt to circumvent the restrictions on play by any persons located in a Prohibited Jurisdiction or Restricted Jurisdiction, is a breach of this Agreement. An attempt at circumvention includes, but is not limited to, manipulating the information used by BCH.games to identify your location and providing BCH.games with false or misleading information regarding your location or place of residence.

TERMS OF USE TERMINATION

GENERAL TERMS

Before using our website, please read this Privacy Policy carefully. INFORMATION COLLECTED

The Personal Information which we may request to use and process shall include, without limitation:

Any of the information that you provide to us when filling in the forms on our account, as well as any other data that you further submit via the Website;

Correspondence made with us via the Website, e-mail, web chat, Twitter or through other means of communication;

All Player Account transaction history, whether this takes place via the Website or via other means of communication;

Website logins and their details, including traffic data, GeoIP location data, browser/device data, weblogs, activity logs and other traffic information recorded in our system;

Survey participations or any other customer assessments that we may carry out from time to time.

USE OF INFORMATION

We process the Personal Information that you provide to us in order to deliver our services. In particular, we will use your data for the following purposes:

Processing your games and transactions.
Providing you with gaming and other services that you seek from our Website;
Rendering customer support, such as assistance with setting up and managing your account;
Undertaking necessary measures for User Account security and to identify the required verification checks;
Providing registered players with information about our promotional offers.

Monitoring and investigating transactions for the purposes of preventing fraud, terms abuse, money laundering and other illegal or irregular gaming activities;
Analyzing customer trends through market study assessments (participation in surveys is not obligatory and you can always choose not to take part);
Conducting research and statistical analysis of aggregated data.

PROMOTIONAL

Unless you have selected not to receive promotional materials, we may use your Personal Information, including your email address, to send you marketing communications regarding products, services and promotions. Whenever you decide to stop receiving such marketing and advertising material, you may opt out of this by contacting our customer support on Twitter: @BCHdotgames

Additionally, note that by accepting any contest prize or winnings from us, you consent to the use of your name and/or nickname for advertising and promotional purposes without additional compensation, except where prohibited by law.

PERSONAL INFORMATION

We shall not collect any Personal Information about you without your knowledge. We may, however, automatically collect certain data about you where you would have provided such information through the use of our services and through your interactions with us.

We may also lawfully receive certain Personal Information from online vendors and service providers. In addition, we retain the right to engage the services of third-party providers to render technical support, so as to process your online transactions and source gaming content.

We shall always use our best efforts to ensure that your information and data is treated securely and in accordance with this Privacy Policy.

RELEASING DATA TO THIRD PARTIES

We do not sell or rent your personal data to third parties. We may also disclose your personal information to a regulatory or law enforcement agency if we believe it to be necessary to protect the legitimate interests of the Company, its customers or any third party.

We use third-party data processors to hosting limited personal data on our behalf. Such service providers support the Website, especially relating to accessing and operating the websites, marketing, analytics, improving the websites, and sending email newsletters. We shall ensure that the transfer of the Personal Data to the recipient is compliant with applicable Data Protection Legislation and that the same obligations are imposed on the processor as is imposed on us under the respective Services Agreement.

DATA RETENTION

As stated under our Terms and Conditions both you and we can decide to have your personal account closed at any time. Following closure of your account, we will retain your personal data on record for as long as required by law. This data shall only be used should it be required by competent authorities in cases of enquiries regarding financial and fiscal records. Fraud, money laundering or investigations into any other illegal activity.

You are not to delete that due to anti-money laundering regulations we are obliged to retain personal data of players submitted during registration and any data passed on during the operative period of a Player Account for a minimum of five years from last player transaction or account closure. Therefore, requests for erasure prior to the lapse of this period cannot be entertained.

Being committed to providing secure services to players we will take all reasonable precautions to ensure that all the data that you have submitted via the Website remains safe.

Player Accounts can only be accessed with the player's e-mail and one-time password. You may also set up two-factor authentication (2FA) as additional protection from unauthorized use of your account. You are responsible for keeping your login information confidential and making sure it cannot be accessed by another person.

PERSONAL INFORMATION DISCLOSURE IN CASE OF FRAUD

In case if we find out the client's involvement into any type of fraudulent actions, such as game manipulations, payment fraud, provision of a faulty personal information, money laundering, use of stolen credit cards or other, the company reserves the right to disclose the player's personal information to third parties or make it public.

ANTI-FRAUD

We use special anti-fraud methods to prevent any type of financial fraud on the website. Any attempts to take fraudulent actions will lead to immediate termination of the player's account. We reserve the right to determine any claimed bonuses or promotions, competition entries or accounts which connected to the same person, using all the appropriate means. In case any multiple accounts have been used, we immediately abolish any bonuses and bonus winnings, furthermore terminate such accounts and withhold promotional benefits the player ever had.
